

DECLARATION OF HONOUR REGARDING EXCLUSION CRITERIA

Reference: The Customs Department under the Ministry of Finance of the Republic of Lithuania (hereinafter – the Contracting authority).

Public procurement procedure "Development, maintenance and support services of Tax Accounting and Control Information System" by open procedure, announced on 8th of April 2016 via CVP IS, procurement No. 173176

The undersigned confirms that, to the best of his/her knowledge, AS Helmes or its directors or any other person who has powers of representation, decision or control of the named organisation:

- a) has not been convicted of any of the following offences in the last five years: participation in criminal organisation; corruption; fraud; money laundering; terrorist offences or offences linked to terrorist activities; child labour or other forms of illegal trafficking in human beings;
- b) has not failed to comply with applicable environmental, social or labour laws in the last five years;
- c) is not guilty of grave professional misconduct, which renders the supplier or tenderer's integrity questionable;
